

## **50% First Deposit Bonus Terms and Conditions**

These 50% First Deposit Bonus Terms and Conditions govern the promotional offer provided by UTO Capital Ltd. By claiming, receiving, or using the 50% First Deposit Bonus, the client confirms that they have read, understood, and agreed to these Terms and Conditions, together with the Company's Client Agreement, Risk Disclosure, Privacy Policy, and any other applicable legal documents.

### **1. Promotion Overview**

UTO Capital Ltd may offer eligible clients a 50% First Deposit Bonus as a trading credit when they create an account and make their first deposit with the Company.

The bonus is calculated as 50% of the client's first deposit amount, subject to a maximum bonus cap of USD 500.

For example, if a client deposits USD 1,000, they may receive a USD 500 bonus. If a client deposits USD 5,000, the bonus will still be capped at USD 500 and no higher bonus amount will be granted.

This promotion is valid only for clients residing in certain countries, as determined by the Company from time to time. Clients from countries where the promotion is not available, restricted, or prohibited shall not be eligible to claim or receive the bonus.

The bonus is not a cash deposit and cannot be withdrawn directly. Only profits generated from trading with the bonus may be withdrawn, subject to the conditions set out below.

### **2. How to Claim the Bonus**

Clients may claim the 50% First Deposit Bonus by :

- a. clicking the promotional button included in the Company's email communication;
- b. emailing the Company's support team at [support@utocapital.com](mailto:support@utocapital.com).

The bonus is subject to the Company's approval. Once approved, the bonus will be credited to the client's trading account after the client has successfully created an account, completed the required verification procedures, and made their first deposit.

UTO Capital Ltd reserves the right to reject any bonus request at its sole discretion, including where the client does not meet the eligibility requirements, where the promotion is not available in the client's country of residence, or where suspicious, abusive, or fraudulent activity is identified.

### **3. Eligibility**

The 50% First Deposit Bonus is available only to clients who meet the eligibility criteria determined by UTO Capital Ltd.

Unless otherwise approved by the Company:

- a. the promotion is available only to clients who create an account and make their first deposit with the Company;
- b. the promotion is limited to one bonus per client;
- c. the client must reside in a country where the promotion is available, as determined by the Company;
- d. the client must complete all required registration and verification procedures;
- e. the client must provide accurate, complete, and valid information;
- f. the client must not create multiple accounts to claim the bonus more than once; and
- g. the client must comply with these Terms and Conditions and all applicable Company policies.

The Company may request additional information or documentation before approving or crediting the bonus, including documents required to verify the client's country of residence.

### **4. Bonus Amount**

Eligible clients will receive a trading credit equal to 50% of their first deposit amount, up to a maximum bonus amount of USD 500.

For the avoidance of doubt, the maximum bonus that may be granted under this promotion is USD 500, regardless of the amount deposited by the client.

Examples:

- a. if a client deposits USD 500, the client may receive a USD 250 bonus;
- b. if a client deposits USD 1,000, the client may receive a USD 500 bonus; and
- c. if a client deposits USD 5,000, the client may receive a maximum bonus of USD 500 only.

The bonus:

- a. is provided as trading credit only;
- b. is not considered a client deposit;
- c. is not withdrawable;
- d. cannot be transferred between accounts or clients; and
- e. may only be used for trading purposes in accordance with these Terms and Conditions.

The Company may set minimum deposit requirements, country-specific eligibility conditions, or other conditions for this promotion at its sole discretion.

## **5. Validity Period**

The 50% First Deposit Bonus is valid for 15 calendar days from the date it is credited to the client's trading account.

After the 15-day period expires, the bonus may be automatically removed from the client's account.

Any open positions connected to the bonus may be affected by the removal of the bonus. Clients are responsible for monitoring their account, margin level, open positions, and expiry date of the bonus.

## **6. Withdrawal of Bonus and Profits**

The 50% First Deposit Bonus itself is not withdrawable under any circumstances.

Only eligible profits generated from trading with the bonus may be withdrawn, provided that the client has satisfied all applicable conditions under these Terms and Conditions.

The Company may impose a maximum profit withdrawal limit in relation to this promotion, at its sole discretion. Any profits exceeding the applicable limit may be removed from the account or may not be eligible for withdrawal.

## **7. Prohibited Practices and Bonus Abuse**

The Company strictly prohibits any form of bonus abuse, manipulation, or fraudulent activity.

Prohibited practices include, but are not limited to:

- a. creating multiple accounts to claim the bonus more than once or transferring the bonus between accounts or wallets;
- b. using false, misleading, or duplicate registration details;
- c. using the same IP address, device, payment method, or identification documents across multiple accounts for abusive purposes;
- d. hedging between accounts;
- e. arbitrage trading;
- f. coordinated trading between related accounts;
- g. exploiting technical errors, price latency, or system delays;
- h. opening and closing trades solely to meet the minimum requirements without genuine trading activity;
- i. depositing funds solely to receive the bonus and withdrawing the deposit without genuine trading activity; and
- j. any trading activity considered abusive, suspicious, or inconsistent with fair market practice.

If the Company suspects bonus abuse, it may cancel the bonus, cancel profits generated from the bonus, reject withdrawal requests, suspend the account, or take any other action permitted under the Client Agreement and applicable law.

## **8. Cancellation or Removal of the Bonus**

UTO Capital Ltd may cancel, remove, or adjust the bonus and/or any profits generated from it if:

- a. the client breaches these Terms and Conditions;
- b. the client breaches the Client Agreement or other Company policies;
- c. the client provides false or misleading information;
- d. the client engages in prohibited trading practices;
- e. the client fails to meet the withdrawal conditions within the 15-day period;
- f. the bonus was credited due to an error;
- g. the client withdraws the first deposit before satisfying the promotion requirements; or
- h. the Company is required to do so for legal, regulatory, risk, operational, or compliance reasons.

## **9. Risk Warning**

Trading forex, CFDs, gold, silver, and other leveraged products involves a high level of risk and may not be suitable for all clients.

The 50% First Deposit Bonus does not remove or reduce the risks associated with trading. Clients may lose profits generated from the bonus and may be exposed to losses when trading with deposited funds and/or bonus credit.

Clients should ensure they understand the risks involved before trading.

## **10. Amendments and Termination**

UTO Capital Ltd reserves the right to amend, suspend, cancel, or terminate this promotion and/or these Terms and Conditions at any time, subject to applicable law and regulatory requirements.

## **11. Conflict with Other Terms**

These Terms and Conditions apply specifically to the 50% First Deposit Bonus.

In the event of any conflict between these Terms and Conditions and the Client Agreement, these Terms and Conditions shall apply only in relation to this promotion, unless otherwise required by applicable law or regulatory requirements.

All other matters shall continue to be governed by the Client Agreement and the Company's applicable legal documents.
